ITEM NO. 1: To confirm the minutes of the 29th meeting of the Council held on 28th July, 1989 and adjourned meeting held on 17th August, 1989.

The proposal of Dr. H.N. Sethna to drop the word !unanimously! from page 9 of the minutes was accepted.

TTEM NO. 5.1: To consider review of the scales of fees/
receipts for services rendered like fees
in educational institutions etc. taking
into account the increase in the cost of
services.

The Council approved the proposals of the Directors of IITs regarding the revision of fees and other receipts for services. The Council decided that the proposal may be implemented from the forthcoming academic year for the fresh entrants and the fee structure should be reviewed every three years. It was also decided that the items under the proposal for fee revision should be re-grouped to make the exercise simpler.

The Council recommended that the question of providing low interest loans to IIT students may be examined by a Committee consisting of the representatives of the Ministry of Finance, IITs and the Department of Education. This Committee should also examine ways and means to increase the income generating capacity of IITs. The Council noted that a Task Force under the Chairman-ship of Prof. C.S. Jha has also examined similar issue under the agies of the AICTE and desired that its report may be made available to the Committee to be appointed by this Council.

The Council recommended that IITs should consider other means to raise resources like establishment of Chairs, consultancies etc. The ways to reduce mess subsidy also need to be explored. Shri Anil Bordia asked IIT Directors to improve the quality of food served in hostels of IITs. Dr. V.S. Arunachalam suggested that the model of messing being followed in IISc., Bangalore could be examined.

It was pointed out that the administrative staff in the IITs was excessive and placed a financial burden. Education Secretary was of the view that the Visitor's order regarding non-expansion of administrative staff in the IITs should be implemented by the IITs and efforts should be made to reduce this cadre.

ITEM NO. 5.2: Introduction of an All India Fellowship Examination (AIFE) for research scholarship in the Departments of Humanities and Social Sciences at the IITs.

Prof. Yash Pal was of the view that it not advisable for students to take a large number of tests for admissions in various courses. A test earlier conducted by CSIR has been merged with the test being conducted by UGC. He proposed that IIT could also be associated with the Jr. Research Fellowship (JRF) Test being conducted by UGC-CSIR. It was pointed out that the timing of the results of the JRF test were not suitable for admission to IIT system. Prof. Yash Pal said that UGC would be holding the JRF examination twice a year and this problem would be resolved.

The Council decided that the test being conducted by the UGC-CSIR should be utilised by the IITs. For this purpose it was also decided that the IITs and UGC would interact in the holding of these tests.

ITEM NO. 5.3: To consider proposal for providing Joint Entrance Examination (JEE) question papers in Indian languages.

It was decided that the decision of the 29th meeting of the Council that 'the question paper of JEE 1990 will be provided in two languages i.e. English and Hindi as a transition measure' may be continued for another three years. The decision may thenbe reviewed in the light of experience gained.

ITEM NO. 5.4: To consider request from University Grants Commission for providing Plan funds to inter-university centres for facilities used by IITs.

Recognising the importance of the facilities created at the inter-university centres, the Council endorsed participation of IITs in the work of these centres. IITs, in turn, would also make their major facilities available to universities for research. It was agreed that the Ministry may consider making funds available from its scheme of Thrust Areas of Technical Education to the Inter-University Consortium set up by UGC.

ITEM NO. 5.5: Simplification of procedure of payment of contributions towards leave salary and pension etc. in the case of staff members who were employed in Central and State Governments before joining the IITs.

The Council did not agree to/proposal. It was further decided that the past service will be counted for pensionary benefits as per the procedure laid down in the earstwhile Department of Personnel & Administrative Reforms O.M.No. 28/10/84-Pension Unit dated 29.8.1984 amended from time to time.

ITEM NO. 5.6: To consider the recommendations contained in the 81st Report of the Rajya Sabha Committee on Subordinate Legislation regarding the Conduct Rules made under the Statutes of the IITs, Delhi.

The Council unanimously decided that no change was required in the existing Conduct Rules of IITs.

ITEM NO. 5.7: To consider analysis of intake of SC/ST students in IITs.

The Council noted the efforts being made by the Government and the IITs to improve the intake of SC/ST students in the IIT system.

ITEM NO. 5.8: To consider proposal for revision of pay scales etc. of Group 'A' Scientific/ Design staff in the IITs.

Shri S.K. Ray, Deputy Financial Adviser pointed out that the Financial Advisers were competent to approve only the replacement scales of the IVth Pay Commission. The IIT Council had agreed for parity between the pay scales of Scientific/Technical Staff with faculty positions at its 25th meeting held on 30th March, 1985, which pre-dates both the IVth Pay Commission and the revision of pay scales of IIT Faculty. Moreover, there is no formal Government decision granting this parity.

The Council noted the views of Prof. C.N.R. Rao received by telex that qualified and deserving scientific officers be transferred to the regular academic cadre as Professor or Associate Professors and the Scientific officers cadre may not be given the same salary as that of the Professorial cadre. Dr. V.R. Gowariker, expressed the view that there should be comparability in pay, qualifications and promotional avenues for the Scientific/technical staff working at IITs with those working in the scientific institutions under CSIR, BARC, DRDO etc.

Prof. Yash Pal, said that granting the suggested scales would lead to disaffection at the middle levels in other institutions. Another solution is to give more avenues for promotion.

Shri Anil Bordia was of the view that parity could be established upto Associate Professor level, but tough selection procedures with posts being open to outsiders should be established. Prof. N.C. Nigam said that there was need to establish a frame work where the best of people could join and grow.

After detailed discussion it was decided to constitute a Committee consisting of Prof. N.C. Nigam, Dr. V.R. Gowariker, Dr. V.S. Arunachalam and Prof. S.K. Shrivastava which could make appropriate recommendations keeping the above points in view.

## ITEM NO.5.9: To consider recommendations of the IIT Review Committee - implementation thereof.

The Council endorsed the recommendations of the Empowered Committee of Secretaries on the nine recommendations of the Review Committee which had been examined by them. These recommendations numbering 17,19,20,22,24,25,26,36 and 42 may now be implemented by the Government/IITs after obtaining the required financial approvals, wherever necessary.

The Council endorsed the 48 recommendations of the Review Committee numbering 1 to 15,18,23,27,29 to 33,35, 37 to 39,41,43,46,47,55 to 58,60,62 to 64,66 and 74 which fall within the purview of the IITs. The IITs may implement the same after obtaining the financial approvals wherever required.

The Council could consider only recommendation No.

16 of the Review Committee out of the remaining eighteen recommendations on which the views of the Sampath Committee and comments of the Committee of Chairmen, Board of Governors and Directors of IITs were to be examined.

With regard to recommendation No.16 the Council decided to continue the existing three semester pattern presently being followed. The Council, however, recommended that the M.Tech. students should have a reduced summer vacation of only 30 days so that they have more time for project work.
